Rules & Regulations

- 1. Contestants must meet the deadline requirements established by KAFHS. Candidates who fail to meet the deadline will not be allowed to compete in the state pageant.
- 2. An entry form for the pageant shall be available to Association members prior to June 1. Completed entry forms should be submitted (electronically) to the Secretary within 30 days of the local pageant and must be received by December 1. No entries will be accepted after December 1. Contestants not meeting that deadline will not be allowed to compete in the state pageant.
- 3. The contestant must be a natural born female, single, married, divorced or widowed and can have children. A birth certificate is required.
- 4. Contestant must be 22 years of age on October 31, of the year when local pageant is held at the local fair.
- 5. Contestants may not compete in any other pageant system that would prohibit the fulfillment of responsibilities through the state during her reign as Ms./Mrs. Kentucky County Fair.
- 6. Kentucky (KAFAS) its affiliates, volunteers are not to be held responsible in any way for disqualifications of winners and/or contestants. Grounds for disqualification can be BUT are not limited to untrue statements or registration forms, misconduct, obscene, foul language, unruly/unbecoming behavior that on social media and/or the internet such as porn and any other reasons the pageant committee may deem as necessary. The board will make all decisions and they will be final.
- 7. Cameras, cell phones, iPad, and other electronic devices are not allowed backstage. Use of these electronic devices can disqualify. Any contestant during the pageant and such devices will be confiscated for the remainder of the pageant.
- 8. Clothing for the pageant will be MODEST, meaning no cut outs in the attire, very MODEST cleavage showing in all attire (no low cut in tops that go to belly button), no slits will be allowed higher than mid-thigh, no see-through attire.
- 9. Pageant year 2025 Mrs./Ms. Will compete together with one winner being crowned Mrs. Ky County Fair and one being crowned Ms. KY County Fair along with 1st, 2nd, 3rd, and 4th runners-up in each category along with a Miss Congeniality in each category.
- 10. Winner will be required to participate in the annual "Miss County Fair of Kentucky" beauty pageant that will be held at the Annual participate she is required to return all gifts and monetary prizes including, but not limited to, crown, sash and jewelry to the Alexandria Fair Convention of the Kentucky Fair Association in Louisville, Kentucky in January. If for any reason the winner cannot.

- 11. Open to residents of Kentucky.
- 12. Attend Pageant on Sunday, July 28, 2024. Contestants must be in the dressing rooms at the Fairgrounds by 1:15 pm dressed for interview.
- 13. The Pageant Committee reserves the right to dismiss at any time any contestant who does not show the proper amount of cooperation and courtesy to Committee members, consultants, judges, or fellow contestants. Any conduct deemed unbecoming by the Pageant Committee will automatically disqualify a contestant.
- 14. Clothing required: Interview, Fun Fashion and a long Formal Gown.
- 15. The decision of the judges is final. Contestants will be judged on poise, personality, and beauty. The winning contestant must agree to appear at the Fair event in 2024 and 2025.
- 16. EARLY SPECIAL Entry fee is \$50.00 (Non-Refundable). Must accompany the entry form by JULY 16, 2024.
- 17. JULY 17 JULY 23, 2024, Non-Refundable entry fee is \$60.00 must accompany the entry form.
- 18. No entries will be taken after July 23, 2024.
- 19. Entries are limited to 25 contestants.
- 20. Agree to participate in assigned Fair activities for 2024 and 2025.
